180 - 101 days prior to departure: No penalty except for initial deposit amount

70 - 0 days prior to date of departure: No refunds

General Tour Conditions

1. **Passport:** In order to travel, a valid US Passport is necessary. Anyone not having a US passport is **RESPONSIBLE TO OBTAIN THEIR OWN VISA** to the country being visited. Passports must be valid 6 months after return date.
2. **Not Included in Tour Price:** Customs, visa fees, optional tours, excess baggage charges, travel insurance, tips, drinks and food other than what is mentioned as part of the itinerary, as well as all other items of a personal nature and any other service not specifically mentioned in the itinerary. Service charges at hotels and restaurants have been prepaid. Tips are not included in the price, including the customary tip to your escort and driver.
3. **City Taxes in Europe:** With the introduction of city taxes throughout various cities in Europe, guests will be obliged to pay these taxes directly to their hotel; either on arrival or at check-out. Costs will vary as taxes are dependent on city, star rating, length of stay, and seasonality. We advise guests traveling to Europe to conduct an advance check on the web with the relevant city tourist board. Cities currently affected include Rome, Venice, Florence, Milan, Amalfi Coast, Ancona, Amsterdam, Paris and some others that may not be listed.
4. **Refund and Deviations and Changes of Tour Arrangements:** Unused hotel accommodations or any tour segments or services are non-refundable, nor can they be changed for other accommodations or services. If there is to be any reason to change features of the tour for the group, any additional expenses will be charged to the tour members. If a change becomes necessary for any reason, hotels substituted will be the equivalent of those shown. Prices quoted are for double occupancy.
5. **Rooming:** Bove Continental Travel will do its best to pair together passengers willing to share a room. If this cannot be arranged, the passenger is responsible for the single supplement charge.
6. **Air Fare:** Are fares quoted are subject to change without notice and are based on fares in effect. Late bookings can be accepted however, may be subject to higher fares.
7. **Responsibility Clause:** Bove Continental Travel is responsible to you in making arrangements for the tour services offered in this brochure, including transportation, sightseeing, and hotel accommodations. Bove Continental Travel reserves the right to make changes to the itinerary whenever it deems it necessary for the comfort, convenience or safety of the tour participants, and to cancel a tour at any time. If Bove Continental Travel cancels a tour, it shall have no responsibility beyond the refund of all money paid to Bove Continental Travel by the tour participant. The tour participant agrees that Bove Continental Travel shall not be liable for any damages, loss (including personal injury, death, and property loss) or expenses occasioned by any act or omission of any supplier providing tour services of any other person. No person, other than an authorized representative of Bove Continental Travel by a document in writing, is authorized to vary any term or condition in regards to this tour, including any term or condition set forth in the preceding provisions.
